

# COA REGISTRANT PORTAL

As part of our relaunch as the College of Opticians of Alberta (COA), we have implemented a new database platform to update the COA's infrastructure, enhance security, and provide cloud-based support to registrants. The first phase of implementation includes the following changes:

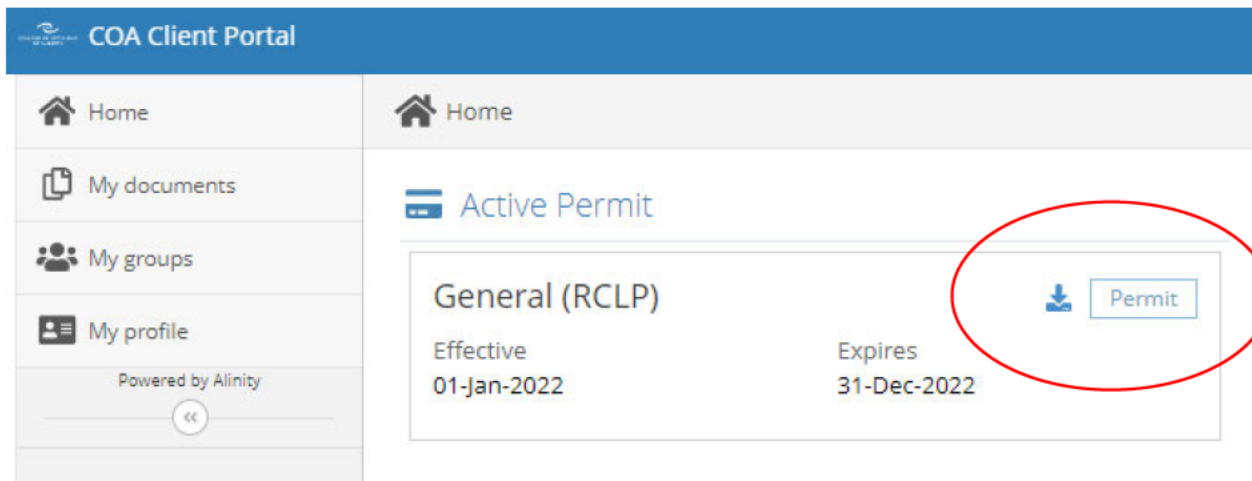
1. New COA Registrant Portal for profile updates, tax receipts, and permits
2. Two-factor authentication for enhanced security
3. New Public Directory of registrants

## Navigating the Portal

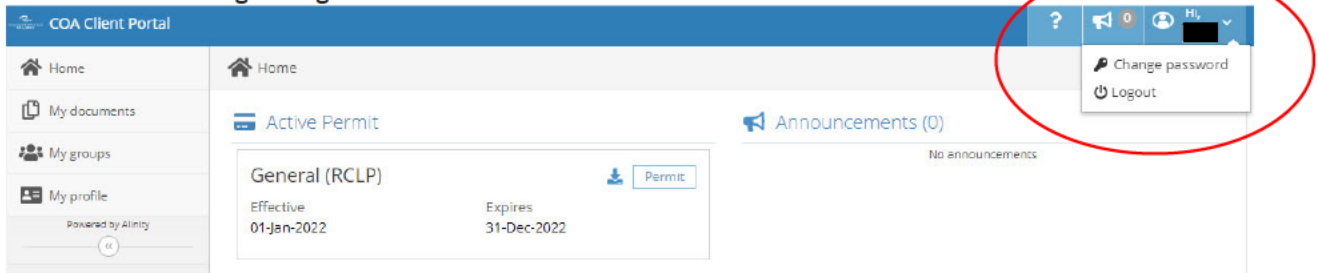
### Permit to Practice

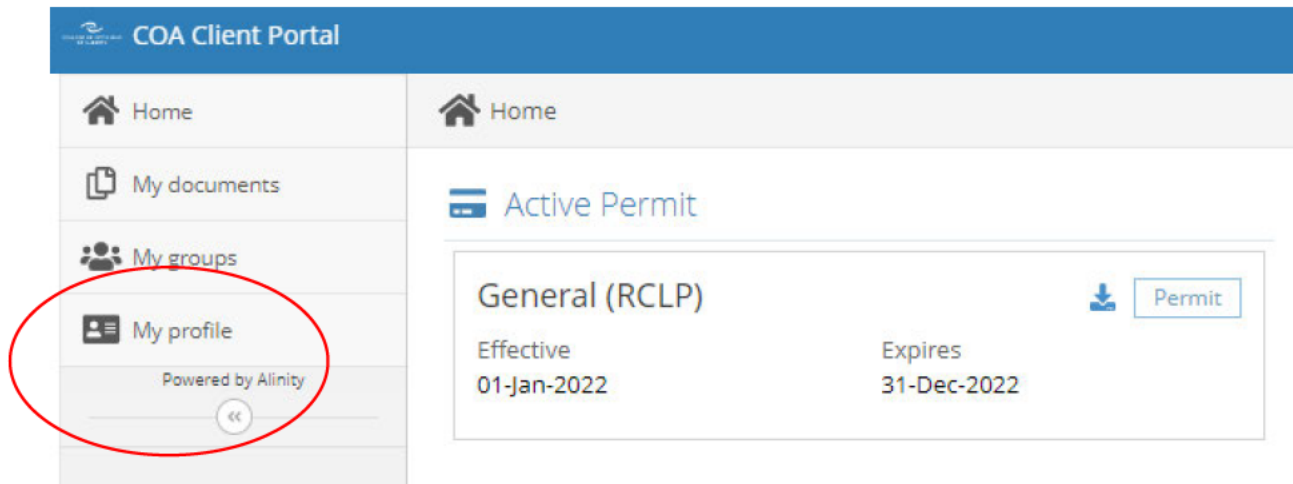
### Changing Your Password

You may update your password at any time by selecting your name in the top right-hand corner of the screen and selecting Change Password:



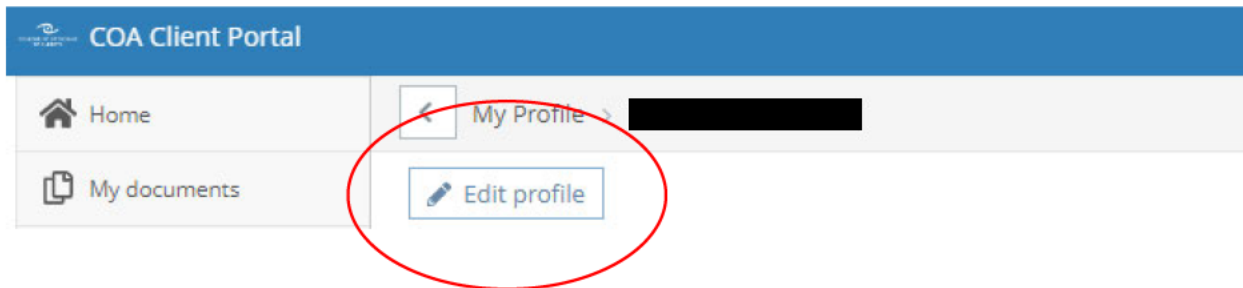
## COA Profile

On the left-hand side of the screen, you will see three menu items. Please note that My Documents and My Groups are not yet activated for registrants. Click the My Profile menu to view your COA profile.



## Updating your Profile

You may update your COA profile at any time by selecting Edit Profile at the top of the screen:



The profile update form allows you to submit changes to your COA registrant profile. Upon submission, updates are either automatically applied to your profile or referred to COA staff for review. Upon review, staff may accept, decline, or return the submission to you for additional clarification or information.

All required fields (marked with a red asterisk) must be completed before the profile update form is submitted. In order for the updated information to be submitted to the COA, you must hit the "submit" button located at the bottom of the form. You can select "withdraw" at the bottom of the form to cancel your submission.
