

# **Practice Management Standards**

Opticians must understand the ethical and legal requirements of managing an opticianry practice to ensure patient and staff safety and quality of professional services.

# **Patient Expectations**

The **patient**<sup>1</sup> can expect that opticians manage their practice ethically and in accordance with legal obligations to promote the health and safety of patients and staff.

# Regulated Member<sup>2</sup> Requirements

1. An optician is accountable and responsible for abiding by the ethical, clinical, and legal requirements of professional practice.

#### An optician must:

- 1.1. be registered with the College of Opticians of Alberta (COA) in accordance with the regulations and have access to appropriate equipment to provide **opticianry services**;
- 1.2. adhere to the occupational health and safety legislation and requirements;
- 1.3. adhere to and have policies in place that comply with all privacy legislation;
- 1.4. delegate tasks to regulated or unregulated staff who are appropriately skilled and competent, and supervise as required; and
- 1.5. put the best interest of the patient ahead of their own best interests.
- 2. An optician is responsible and accountable for implementing and following infection prevention and control (IPC) interventions.

#### An optician must:

- 2.1. understand the chain of transmission and their role in breaking that chain;
- 2.2. have access to hot and cold running water, or an appropriate alternative for hand hygiene in the dispensing facility (such as alcohol-based hand rub);
- 2.3. incorporate and perform IPC best practices; and
- 2.4. take reasonable and appropriate measures to minimize the risk of contamination and subsequent transmission of infectious agents in all areas of practice.
- 3. An optician is responsible and accountable for understanding and adhering to all billing and third-party agreements.

#### An optician must:

- 3.1. ensure all fees are explained to patients and they have highlighted where insurance plans do not cover costs; and
- 3.2. sign insurance forms or submit insurance claims, on behalf of the patient, using medical benefits ethically and in accordance with the law.

4. An optician working in a dispensing facility must have access to ophthalmic instruments appropriate to the professional services being offered at the facility.

An optician must:

4.1. be responsible for ensuring that all equipment is in good working condition and is used, disinfected, and maintained according to the manufacturer's instructions.

# **Glossary Terms:**

Chain of transmission: how microorganisms are transmitted from one person or place to another

**Patient**: a person, or caregiver of a person, receiving professional services from a regulated member of the College

**Opticianry service**: a service that comes within the practice of the regulated opticianry profession. In their practice, opticians do one or more of the following:

- based on an optical prescription, design, supply, prepare, adjust, and dispense optical appliances and prostheses, including corrective lenses;
- promote eye health and the correct use of optical appliances and prostheses through education of consumers and regulated members;
- perform refractions and identify the need for corrective lenses;
- conduct or collaborate in optical related research;
- when providing opticianry services referred to in this section, conduct assessments and make referrals where appropriate;
- provide restricted activities authorized by the regulations.

(Opticians Profession Regulation, 2011)

**Regulated member**: an optician registered as a member of the College of Opticians of Alberta under section 33(1)(a) of the HPA (2000).
